Your age counts, but which age counts for your pension?



This used to be a lot simpler. You had the state pension age (AOW age) and your retirement date, and this was the age of 65 in both cases. However, so many different ages are now used for your pension that you can no longer figure out when you'll be able to retire! Let's begin with the ages determined by the government, for example the progressive state pension age. If you were born after 31 December 1954, the state pension age is currently 67 years and three months. If you were born before this date, your state pension age will be between the ages of 66 and 67. According to the latest reports, the state pension age of 67 years and three months will apply until 2024. It may be increased again from 2024.

This is also convenient if someone else attends to your administration. Each time a message arrives, you will be sent a notification that there is mail for you in "My SPF pension".
