Good news! Maximum pension increase in 2022



Just before the holidays, let's start this newsletter with the good news. Back in March, we brought you good news about the [decision](#) to partially increase pensions in 2022. We can now provide even more good news: On June 10, SPF's Board decided to grant full indexation as of 1 July 2022 to all members. This indexation applies to the year 2021.

We will soon start sending out the Uniform Pension Statements. You will receive your UPS in your digital mailbox in ['My SPF Pension'](#) or in paper form at your home address if you have indicated that you do not want to use SPF digital mail).As we cannot send out all the UPSs at once, we are starting with employees and pensioners.

We are obliged to send separate UPSs if you already receive a full or partial pension payment or if you are a member of several schemes. It can, therefore, be the case that you receive multiple UPSs at different times. We will be sending out UPSs until the end of September.
