Introducing: two new SPF AC members

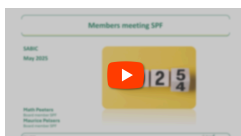

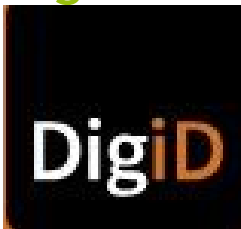

DigiD: what do I need it for?



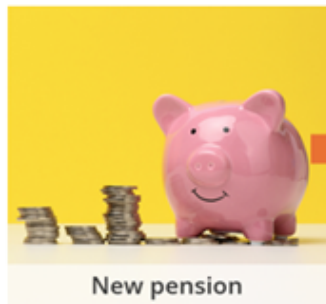
